### APPROVAL OF DECEMBER 2017 EDA FINANCIALS

Ms. Hansen reviewed the December 2017 cash balances and loans for the EDA. For the cash balances, she noted increases in Fund 201 and 203; no change in Funds 202 and 204, Small Cities activity is reflected in funds 206 and 208, and Fund 207 reflects operational dollars from which there are two active loans. Ms. Hansen reported that NBC Bank, the financial holder of the Rivdogg

Avenue C Loan (a business that closed in late October 2017) will be proceeding into the collections process. Ms. Hansen stated that NBC/Cloquet sold off the SBA 75% guaranteed portion of the loan day 2 of the loan and Commissioner Shelly Peterson confirmed the outstanding 25% was \$18,040.80. President Ross Peterson asked for a motion to approve the December 2017 Cloquet EDA financials.

### Transfer tax forfeit property for Acquisition Rehabilitation for Affordable Housing

Ms. Hansen summarized the partnership working with the County to transfer viable tax forfeit properties for various strategic goals of the City. In the case of 302 North Road, for affordable quality housing rehabilitation. Therefore, the County has accepted the offer from One Roof Community Housing for 302 North Road and as such the property will be transferred to the City and then to One Roof. President Ross Peterson asked for a motion to approve.

Motion: Commissioner Schultz moved, and Commissioner Ross Peterson seconded, that

the transfer of tax forfeit property be approved backing the Cloquet EDA's

housing goals. (Motion passed 5-0).

# **Water Tower RFP**

Ms. Hansen provided an update that public works crews had removed the former water tower footings, as utility shed, and would be removing other items during the 2018 construction season providing a clean slate for development. This uncertainty was a barrier during the last RFP cycle. President Ross Peterson asked for a motion to approve.
