Ms. Butcher reviewed the 2015 Goals with the EDA and distributed stickers priming them that they'd need to vote on priorities for 2016 during the meeting. To start, she asked each Commissioner to speak, sharing their general thoughts on issues they felt the EDA should be focusing on for 2016.

Commissioner Wilkinson shared that a stronger EDA- local business networking is needed to further the Cloquet Business Park's development. She thought the Facebook page has been successful in business awareness to local Cloquet followers but wondered if the Pine Journal is a missed opportunity to not further utilize to tout the work that is being done? She suggested different approaches are needed for Cloquet Avenue and the West End as they relate to downtown revitalization and which one should we start with - perhaps one that is a smaller more manageable area like the West End? The Avenue C Restaurant will be an important catalyst for that district, perhaps there are also pop-up store opportunities for the holidays or in general throughout the year to stimulate that district especially with storefront vacancies. The EDA needs to create living wage job opportunities which requires us being proactive.

Commissioner Bjerkness said it will be important to establish a vision for downtown and housing redevelopment and downtown revitalization are strongly tied. There are also public realm streetscaping opportunities for Cloquet Avenue and Broadway. He stated that Cloquet Avenue has evolved as a strong service district with some retail while the West End may require a different approach as they are experiencing different issues (hidden, storefront vacancies, working on riverfront connectivity etc.).

Commissioner Ross Peterson expressed interest in working on projects that create single family lots connected to sewer and water for market rate housing opportunities, along with promoting business opportunities in the Cloquet Business Park as his top priorities.

Commissioner Russ Smith said housing projects are important for the EDA to work on and the Middle School adaptive reuse proposal from Sherman Associates is critical for the EDA to continue being a strong part of as a specific goal for 2016.

Mr. Fritsinger said he wonders about the format of economic development with the loss of the CDIC to privately discuss business issues and stated that BRE and supply chain information is critical for staff to continue working on. He mentioned there are also event opportunities working with the Chamber for things like Downtown Sidewalk Days.

Ms. Butcher asked the EDA to vote (staff one color stickers, commissioners had a different color). Voting results were:
