March 2016 Financials be approved. (Motion passed 7-0).

Ms. Butcher provided an update that she and Brenda Nyberg from the County had visited onsite with the Cloquet Home Center owner Bob Goewey and he reported no ability to repay loan debt at this time. Ms. Butcher noted the business has closed and was recently listed for sale with a commercial realtor. President Ross Peterson provided the update that he had met with the owner looking for an update as the EDA President and is comfortable that with the asking price and the amounts due on the Woodlands, SBA, City, and County loans that the City should be repaid in full the \$39,000 outstanding and there will be a cooperative liquidation. There have been several businesses who have toured the buildings and one accepted offer at this time, no specific details available. Ms. Butcher reported the offer was from Friend of Animals (FOA) which the EDA discussed. Mr. Cottingham provided a historical overview of Business Park zoning and changes made last year.

ACTION ITEMS / PRESENTATION / DISCUSSION

HWY 33 RETAIL AGREEMENTS STATUS

Ms. Butcher reported that Ryan Companies had terminated the preliminary development agreement with the City effective 3-31-16. With that, all other agreements the City has in place with DNR and Nels Nelson are formally impacted. Requested action from the EDA today will be the request to recommend to the City Council providing formal written notice of termination of Option Agreements between the City and DNR and City and Nels Nelson.

Ms. Butcher reported that financial relocation requirements related to the Cloquet DNR site foremost in combination with retail contraction into urban markets and mall areas had led to stagnant market reactions from both junior and major anchor tenants. As such with no viable leads or paths forward Ryan Companies has terminated their preliminary development agreement with the City.

Ms. Butcher reported that she and President Ross Peterson traveled to the DNR St. Paul office on March 2nd to touch base on existing site redevelopment interests or options in the Cloquet Business Park and received the update that there are no current plans as the site is not triggered on their system as a major need. Ms. Butcher reported 7 major development chains she spoke directly with during March and their responses to the Cloquet site. Commissioner Schultz stated disappointment with the amount of time and energy invested into the site to get to this point of no leads.

Motion:

Commissioner Ross Peterson moved, and Commissioner Schultz seconded, that the EDA recommend to City Council that the City provide formal written notice of termination of Option Agreements with Nels Nelson and the DNR. (Motion passed 7-0).
