# **ACTION ITEMS / PRESENTATION / DISCUSSION**

### **Cloquet DNR Pre-Design Study**

Ms. Butcher introduced LHB Architectural Project Manager Cynthia Poirier who was hired by the EDA to conduct the Cloquet DNR Pre-Design Study. Ms. Poirier distributed a powerpoint slide summary of the Cloquet DNR Pre-Design Study. She stated that the study was devised collaboratively with the St. Paul and Cloquet DNR offices.

EDA members asked about the current employment levels at the Cloquet DNR office, she responded staffing included 12 FT, 3 PT, plus seasonal staff, and staff affiliated with the Department of Corrections program. In summary Ms. Poirier stated that the current buildings at the Cloquet DNR site range in age from 1957 – 1991. There is currently no circulation within the office and to meet current building code standards the existing 11,020sf building would need to expand to 16,410sf due to those circulation code changes and to account for vacant positions. There were also other critical needs such as a shower/mud room.

Ms. Poirier reviewed the existing DNR buildings onsite, the project goals of the DNR aligning with B3 state sustainability building standards and then she reviewed three different sites in the Business Park, laying out the program needs of the DNR. She stated that the preferred site was the northeast corner of the Industrial portion of the park near the pond. She closed by saying that the goals of the project had been met and the DNR confirmed the Cloquet Business Park is a viable opportunity for them to relocate on. Seasonality is important to them along with other timing needs. She stated that preliminary cost information has been provided to City Staff to further discuss and review with the developer.

Direction: Staff should continue cost discussions with developer and consider next steps with site marketing and DNR.

# **Cloquet Business Park Lot Discussion**

Ms. Butcher presented information on a potential business lead and discussed former lot pricing sheets with the EDA and asked for feedback. Ms. Butcher discussed the type of business and location requested and the EDA responded with the need for retail or strong office presence in the front portion of the business park on lots 9 and 10. Pricing was discussed and EDA members provided Ms. Butcher direction on working with business lead.

## 2015 EDA Work Plan Goals
