



Tribute Tree Program

- & Citizens can purchase a tree for \$150.
- Choice of species: Oak, Maple, Linden, Japanese Tree Lilac, or Elm (disease resistant variety). Diameter will be 1.5 2 inches. *The City will make every effort to provide the species of your choice; however substitutions may be made based on availability of stock.
- Planting location: The donor selects which boulevard or park the tree will be planted in. *Subject to City Approval
- Defanting is done in the spring (May 1-June 15). Application must be in by December 1 (previous year).
- A City crew will plant the tree and care for it for the duration of its life. We ask the property owner to water boulevard trees.
- Tribute Trees are guaranteed for one year; if a tree fails during this time, the City will replace it at no cost.
- The donor, or the donor's recipient, will receive a Tribute Tree Certificate signed by the Mayor of Cloquet and may have a custom message.

Thank you for submitting your application for the 2015 statewide Regional designation application process. The objective of the Greater Minnesota Regional Parks and Trails Commission is to identify facilities that, when complete, will create a comprehensive network of Regional outdoor recreation opportunities for people that enhance and compliment the DNR State Park and Trail system in Greater Minnesota.

The Commission's Evaluation Team (ETeam) reviewed 85 applications in this round of requests for Regional designation. It is the role of the ETeam to help the Commission objectively identify those facilities that meet the high standards for quality established by the Commission. All applications received a Step 1 ranking evaluation, resulting in either a "High," "Medium," or "Low" rank. Applications that ranked "High" become eligible for Step 2 scoring evaluation upon completion of a qualified Master Plan.

Your application has been reviewed and given a "Medium" ranking in this application cycle. The ETeam recognized potential in your facility, however your concept and the supporting information provided did not warrant a full evaluation and scoring of the facility. We encourage you to review the Commission's Strategic Plan when considering changes in your application to meet the high expectation for quality outdoor recreation established by the criteria, if you wish to apply again in the future.

The ETeam did provide the following comments to help you understand their evaluation: Great size and quality, but is not anything unique in features for the region. It is local use primarily and will not be a regional draw based on the variety and quality of recreation amenities in the area. Very good application otherwise.

The Commission wants to be clear: projects that received a "Medium" ranking need improvement before they should be resubmitted for Regional designation.
