Administration/Finance

City staff met with County, MNDOT, and School District staff for continued discussions on the Washington Avenue corridor safety improvements around the new Middle School. The County will be holding open houses soon to gather input on options for the improvements that will be constructed next year. In the interim, the current traffic control measures along with increased Police presence will continue around the school entrance.

Staff continues to work on the new WWW page. We are currently reviewing the existing pages to determine which ones should be moved to the new site or deleted. We are also working on selecting the site design and navigation options.

The League of MN Cities Insurance Trust sent a large number of their staff to town to provide a presentation to Department Heads and other City staff on the various services the LMCIT provides to their member cities. The City switched workers compensation and liability insurance back to the LMCIT in 2018.

Human Resources

The City Council approved the AFSCME and Teamsters Labor contracts at their meeting this week. Both contracts are available on the city's website. Council also approved the Personnel Policies Handbook. This is also on the website to view.

Crews were once again busy with another water leak, this one was on Slate Street near Churchill Elementary. The warmer weather this week has allowed the street crew to start scraping the snow pack off streets.

Engineering held a neighborhood meeting Thursday evening on the proposed Arch Street reconstruction. The meeting was held to discuss the project and collect public comment.

Staff attended the Economic Development Association of Minnesota conference in St. Louis Park on Thursday.

Planning and Zoning

Staff attended a flood plain management workshop to learn the process for updating the 1991 flood maps and the modernization of the system. It appears that this portion of the county will not be updated for another 1.5 to 2 years.

Building Inspections

This week staff held a remote session with PermitWorks to analyze the existing structure of the city's building permit software system in an effort to obtain a more accurate quote for data transfer. Other activities this week include an on-site preconstruction meeting at a local building for a residential remodel, plan reviews, several residential remodel and furnace inspections and follow-up on enforcement cases throughout the City.




Pavement Management Program

- City roadways rated based on their condition, full inventory taken the summer of 2017
- Information used to develop the Pavement Management Program and prioritize projects
- These Roadways have been identified for reconstruction
- Problems include: aging or failing underground infrastructure, poor drainage collection, deteriorated pavement structure, failing retaining walls











Project Funding

- Currently developing estimates
- Permanent Improvement and state aid Funds
 - Street improvements and storm sewer
- Assessments
 - for portions of roadway improvements, sidewalks, sanitary sewer and Water replacements
- City Utility Funds
 - sanitary sewer & watermain

Assessment Policy

- Street assessments are based per front foot
- Utilities assessments are on a per unit basis
- Typical lots in this area are 60 feet
- Street assessment rate estimated at \$35/ft
- Utility assessment rate estimated at \$5,000 per lot
- Total assessment estimated at \$7,100 (typical 60' lot)

Assessment

Payment Options:

- Paid in full without interest within 30 days of the assessment hearing
- Certified and added to property taxes
 - Payment period
 - Street reconstruction 10 yrs
 - Interest rate set when assessment roll is adopted
