Administration/Finance

Bond Sale

The City Council has authorized the issuance of sales tax revenue bonds to help finance some of the upcoming sales tax projects. These projects include the Broadway and Cloquet Avenue Streetscape projects, Dunlap Island Park project, and several other improvement projects. The Council is expected to receive the bids for the \$8.4 million in bonds at its April 4th meeting.

Sunday Off-Sale Liquor Sales

The State of Minnesota recently enacted a new law which will allow for the sale of intoxicating liquor on Sundays. The City Code currently does not allow for the sale of liquor on Sunday so the Council will need to consider whether or not it wishes to align the Code with the State. The City is not required to allow for Sunday sales so it has discretion on this topic. The Council may wish to start thinking about its position.

Safety Committee

The Committee met this week to discuss various employee wellness options. The City has obtained some wellness funding from the Northeast Service Cooperative and the Committee has prioritized the possibility of purchasing AED's for our public buildings. Staff will now research the cost to see how many could be acquired.

Public Works/Parks

Dunlap Island/Broadway Streetscape Project

The Council provided staff with feedback on the design projects this week and staff will now work with our design consultants to get the plans finalized for bidding in the near future. Some work is still taking place with the industries that use this street to make sure any concerns they have about design are being considered.

Skate Park

The City received word that the grant application submitted to the Tony Hawk Foundation was not successful. This grant would have provided up to \$25,000 to be used towards the skate park project.

Community Development

Miscellaneous

Staff continues to research and work on community broadband internet challenges. More meetings are to come with some of our partnering agencies and state officials to determine the realistic options available to the City to improve this critical community infrastructure.

The City and regional partners met with Ady Advantage this week to receive the preliminary marketing study/strategy being developed on behalf of the City of Cloquet. While there does not appear to be any real eye opening issues or suggestions, the data is very solid in terms of its suggestions. Once finalized, the City Council will be provided the final results.

Staff has seen an uptick in communications with potential housing and commercial developers within the community recently. Discussions are being held with several state agencies on some strategies to encourage development along the Highway 33 corridor. Let's keep our fingers crossed that the summer of 2017 becomes a turning point where we finally start to see some larger scale development activity within the community.



To Whom It May Concern:


