Administration/Finance

Public Works/Parks

Work was slowed significantly this week with all the rain. The overlay contractor was able to continue with concrete removals and forming. City crews worked mostly on tree trimming, street sweeping and some indoor projects on the Lake Superior Waterline. We were able to complete one water leak repair on Doddridge before the rain started on Monday.

Community Development

Economic Development

This week the Council approved a required Resolution of Support for Roers Investments to apply to Minnesota Housing Finance Agency for housing tax credit financing for the Adaptive Reuse of the Cloquet Middle School building. Staff attended a meeting with Fond du Lac related to future broadband fiber plans and how those could or could not be leveraged for Cloquet. Being that the recent Ady Advantage Cloquet Marketing report highlighted opportunities in Cloquet for Agribiz/Food processing and transportation distribution, staff reached out to a local trucking company to inquire about opportunities in the Cloquet Business Park. Staff also worked with the Northspan group to ensure Cloquet property listings are up to date for both buildings and land.

Planning & Zoning

This week at the Council Work Session, staff discussed land use zones related to incinerator based crematories and signage regulations in zoning districts related to pylon signs. The Council approved zoning ordinance amendments defining "Special Events" in Cloquet and formalized the vacation of an alleyway in the West End. Staff accompanied the Building Official to various local projects related to new structure placements. Staff also examined locations along Cloquet Avenue that may be appropriate for bump outs and sharrows this summer season.

Building Inspections Services

There have been a significant number of residential inspections this week for roofing, plumbing, insulation, garages, home framing, and HVAC. In terms of building enforcement this week, staff placarded a few homes for utilities going off and requested interior inspections on two properties with complaints. Commercial inspections were conducted for FOA, CMH, and Gordy's. Staff, the City Attorney, and Councilor Kolodge attended another follow-up meeting on a long standing/ongoing discussion on options to address a failed retaining wall entirely on private property affecting 3-4 property owners.
