#### **Administration/Finance**

Our new City Administrator is scheduled to start no later than 2 October! Staff has been in communication with Aaron and have been helping him get up to speed on several items affecting the City.

Staff met with the Library Board this past Wednesday evening and have narrowed the search for a new Library Director to three finalists. Staff will continue to work with the Library Board to orchestrate on-site interviews on September 15<sup>th</sup>.

There is a current opening on the Housing and Redevelopment Authority (HRA). This is a 5 year term and expires on June 30, 2022. More information on the HRA and application can be found on the City's website under Boards and Commissions.

#### **Public Works/Parks**

The Voyageur is back! He is mounted in his new home adjacent to the Spafford Campground. Staff continues to work on a lighting plan, but he is already very visible from Highway 33 in his new location.

Staff will be submitting the City's required Water Supply Plan for preliminary DNR review this week. The plan deals primarily with our historic water use and certain conservation and monitoring efforts with are required under our water allocation permit from the State.

#### **Economic Development**

Staff arranged a tour of a Cloquet office building that will be listed later this fall. The tour was arranged for regional economic development staff (APEX, Northspan, MN Power, City, County) so they are aware of the building as potential leads are inquiring about space. Staff also showed other available Cloquet buildings to local businesses describing space and building opportunities. Several SCDP projects progressed this week and several businesses inquired about programs the City provides. Staff met the Nooter Industrial Power Group this week. They lease space in the Daqota Systems building and several of their staff work out in the field on projects and do not report directly to the building.

#### **Planning and Zoning**

Staff coordinated a tour of the Shamrock Landfill for the City Council this week. It was educational and informative. A good discussion was had on all sides.

#### **Building Inspections Services**

Staff conducted a variety of inspections this week including the Dunlap Island picnic shelter, the Country Club Patio Homes project, improvements at Evergreen Knoll, the CMH Wound Care Facility, improvements at the Cloquet Public Schools, and a variety of other residential and commercial inspections. Staff accompanied Carlton County through the Shaw Library building with their architect noting building improvement needs.

#### Library

The Library will be having a solar eclipse viewing party on Monday, August 21st beginning at noon. Viewing glasses will be provided to those that attend beginning at 11:00 a.m. The moon will start to cross over the sun at approximately 11:45 a.m. People will also be able to view televised coverage of the total eclipse in the library meeting room.
