Staff has begun the process of working with SEH on the various park design improvements planned for 2016.

Staff has also been working with a variety of attorneys on the potential turn back of Reservation Road to FDL. Many discussions regarding the legal authority's to complete such a turn back. However, it does look like a path has been identified which will allow this to move forward.

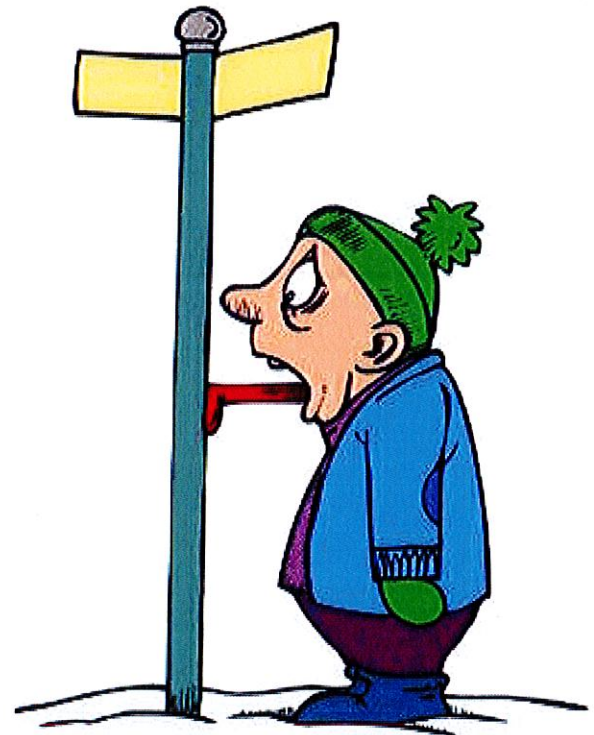
## COMMUNITY DEVELOPMENT

### WHAT WILL THIS TRAINING DO FOR OUR WHOLE COMMUNITY TEAM?

An IEMC places public officials and emergency personnel in a realistic crisis situation within a structured learning environment. The training and exercise experience is tailored around your real-life risks and threats. Why should you and your jurisdiction participate in this training/exercise experience? The course experience will help you and your whole community team find deficiencies in your emergency operations plans, staff knowledge, and EOC operations so that these weaknesses can be corrected prior to an actual emergency. A jurisdictional pre-course analysis will be conducted to collect numerous items such as: location specific information, critical infrastructure, and current response plans. From this, the training and exercise course will be customized to test each jurisdiction's planned approach to specific hazards and to surface issues for which the IEMC participants may need to re-evaluate and develop corrective action plans.
