Obviously with our warm weather, the outdoor skating rinks are now closed. The crew has been busy with street sweeping and filling pot holes.

I-35/HWY 33 INTERCHANGE

Staff met with MnDOT officials this week to continue discussions on possible improvements to the I-35/Highway 33 interchange. Discussions are still focusing on the long term construction of a new frontage road. The State believes that it is highly likely that it will be able to access certain safety funds to cover a large share of the project costs. MnDOT will continue to develop plans and study a variety of issues related to the project.

Best Oil Property Acquisition

Staff continues to work with the McKinney family and our consultant on the Phase 2 Environmental Study on the Avenue B property. This is property that the City has interest in due to its proximity to Veterans Park and the need for additional snow storage during the winter. Staff is hoping to have a final recommendation complete in April.

SPECIAL ASSESSMENT POLICY

Staff has started to review the section of City Code which addresses special assessments. We are looking to change this from Code to a Policy. The Code is used for the various infrastructure improvement projects that the City undertakes each year. Conceptual changes will be presented to the City Council over the next few meetings.

This May 2nd and 3rd, the Minnesota Professional Fire Fighters (MPFF), the state association of nearly 40 Locals which represents over 1700 career firefighters, paramedics, and dispatchers will hold its 81st annual convention at the Black Bear Casino and Convention Center in Carlton, MN.

As part of the conference, and in conjunction with the Cloquet Area Fire District and Cloquet Firefighters Local 880 we will be conducting a one-day fire ground orientation for civilians, elected officials, and representatives of the media. This event will be held Sunday, May 1st from 9:00 am to 2:00 pm at CAFD Station 3 /Training Areas. This program will include actually suiting up in firefighter protective clothing, donning self-contained-breathing-apparatus (SCBA), and actually going inside a real fire to experience first-hand the environment in which firefighters work. You will also have the opportunity to experience the aftermath of a motor vehicle accident requiring patient extrication, and a cardiac arrest scenario. All of this will be in a controlled environment, of course, but nevertheless it will be an opportunity to see and feel what firefighters deal with on a daily basis. It promises to be a very exciting and informative day!

We would be honored if you would consider participating in this activity. We believe this will provide you a perspective on our issues as never seen before. Additionally, the MPFF will provide press coverage so that your constituents know that you are on the front line with us.

Sherman Associates Adaptive Reuse Proposal for the Cloquet Middle School

PUBLIC MEETING & PRESENTATION

Monday, March 21, 2016 6:00 p.m. Cloquet Middle School Auditorium 509 Carlton Avenue, Cloquet

Cloquet students in grades five through eight will be moving to a new middle school in 2017. This will be a great opportunity for our students and community, but we now have to decide what to do with our current middle school. Many communities have faced similar decisions, and in many cases, developers have agreed to repurpose these kinds of buildings to serve a wide range of needs such as housing businesses, becoming centers for arts, or serving various community housing needs.

The District put out a Request for Proposals in October 2015 and in December 2015 received one developer response proposal from Sherman Associates for adaptive reuse of the building into apartments. They presented to the School Board on February 22nd and now this public meeting has been scheduled for the public to learn more about what their plans would be for the middle school.

The meeting will be *Monday, March 21, beginning at 6:00 p.m.* in the *middle school auditorium*. Following the presentation by Sherman Associates, there will be time for questions.

A quorum of the City Council, Planning Commission and Economic Development Authority may be present to listen to this presentation. This meeting is posted as an open meeting under Minnesota Statute.
