Administration/Finance

Personnel

Staff met with AFSCME representatives one additional time this week to hear last comments regarding the City's Personnel Policy Manual. The manual will be presented to the Council on December 6th.

Staff met with the Teamsters to gather further information related to a grievance process.

The City received notice this week that our insurance provider, BCBS, has been unable to reach agreement with our local health care providers. If this situation continues past the first of the year, our local health care providers will no longer be considered in-network which will have a significant impact on employee health care costs. The unfortunate part is that if such an event takes place, the City will be locked in and limited in its opportunities to change its health plan options for 2017 (see attached).

With the year drawing to a close, the annual performance evaluations of employees has begun. This is our first year where evaluations are being completed at one time of the year rather than anniversary dates.

Elections

Congratulations to Kerry Kolodge, Steve Langley and Adam Bailey on being elected to serve the residents of the community for the next four years. Our thanks to Lara Wilkinson for her service and dedication for the past four years.

Laserfiche

The City began installation of a new electronic records management system this week. Laserfiche will allow us to digitize all of the City's documents creating a system that makes it much simpler to find and access information. We are starting the process with Administration, Finance and Human Resources, and will eventually move to other departments and create a portal for general public access.

Community Sign

Staff was able to re-group this week with the National Guard after a long delay in discussions regarding a shared community sign to be conceptually placed at the National Guard Armory. We will continue to work on concepts associated with this project and present them to the City Council at a future meeting.

2016 Financial Audit

Preparation for the year-end audit has already started. Staff has reviewed and executed an Engagement Letter with Wipfli to once again perform this important financial audit. There are no significant changes in the audit methodology.

Public Works/Parks

Winter's Return

After what has been a blessing of a fall, it looks like Mother Nature is going to try and get us back on track for winter this weekend with our first look at snow starting Friday morning. Dunlap Island/Broadway Design

Staff participated in a design workshop with our consulting engineers as the next step in developing designs for the 2018 Dunlap Island and Broadway projects. Following will be a discussion with the Council in December to present the design concepts.

Lake Superior Water Line

Staff met with Sappi this week to continue discussions on station electrical upgrades. The final cost related to the major water line break that was repaired at Knowlton Creek in Superior earlier this fall is estimated at approximately \$204,000. These costs will be reimbursed by the company when water rates are renegotiated next year.

Storm Water (MS4 Permit)

Staff attended a workshop on the St. Louis River watershed and possible regulations that the City may face under our MS4 permit. Right now the areas of concern are not focused on storm water discharge so it does not appear the City will face further regulation at this time

Miscellaneous

Crews are in the process of putting up Christmas decorations with the lights at City Hall being finished this week. The hockey boards at Sunnyside were also erected this week.

Community Development

Marketing Plan

Staff has started working with our consultant, Ady Communications, on gathering information to help develop this economic development marketing tool. Specifically, staff is working to schedule meetings on December 19th and 20th with the consultant and a variety of the stakeholders that have a vested interest in economic development.

Business Development

Holly and Lloyd from Sara's Vac Shack worked together on Tuesday to promote Small Business Saturday on the WKLK morning radio show.

Staff met this week with a McGregor company on site at the Business Park, and staff also met with Consolidated Solutions regarding ongoing efforts to roll out fiber broadband concepts to local businesses, leveraging the NESC fiber line.

Miscellaneous

Staff has been working with Friends of Animals on a retaining wall on the north side of the former County building, which is where they will place exterior kennels once they are in their new location in the spring.

Staff examined wetland issues on the north side of the St. Louis River related to future ATV trail development.

A meeting was held with Prowest to discuss current and future GIS needs as they relate to Public Works and Community Development as well as providing a tour of Cloquet to Northspan and APEX staff showing them buildings with space for lease or sale, along with various lots and redevelopment opportunities in Cloquet.

Integrity Health & Fairview Contract Negotiations

Good morning.

Some of you may have seen the news last night or newspaper this morning with regards to Integrity Health. Also, some of your employees may have received letters from Integrity, Fairview or BCBS regarding out of network status. As many of you know, we must negotiate every 2-3 years with all of our providers. This includes independent providers and providers belonging to large health systems. Sometimes these negotiations get difficult and public. I must assure you that BCBS is doing our best to get these contracts settled. It is possible that these negotiations could go to the 11th hour. We are hopeful the contracts will be settled, but there is no guarantee.

Integrity's contract is due to terminate on 2/1/17, if a new contract is not settled before then.

Fairview's contract is due to terminate on 1/1/17, if a new contract is not settled before then.

It is likely, if not already, that some of your employees will come to you with concerns. There is no need to panic. Like I stated, we are hopeful contracts will get settled. But, employees should prepare to make health care changes, should these providers end up going out of network.
