PERSONNEL

Advertising for the Street Maintenance Person position closed last week and the Parks Maintenance Person position today. The City has received about 30 applications. We received the resignation of Cody Crawford this week so we will be looking for one additional Parks Maintenance Person when I start reviewing the applications.

Staff also was involved with labor negotiations with the CAFD Battalion Chiefs and responding to an employee grievance from the Teamsters.

CITY COUNCIL RETREAT

Supervisory staff met this past week with the City's facilitator to continue development of action steps to implement the priorities identified by the Council at its retreat in April. We are in the process of getting everything cleaned up in terms of the actions and will get the final product out to the Council and posted on the website in the near future.

MURAL

The Library Board has discussed the idea of the historic mural and is supporting it being located at the Library. I'll learn more over the next week as to whether or not the City itself will need to take any action on the Arts Board grant application.

CLEAN UP DAY

Just a reminder that Saturday is Clean Up Day. Staff will be busy working and assisting residents with Clean Up Day at the Shamrock Landfill tomorrow.

PUBLIC WORKS / PARKS

FLOWER PLANTERS

The crew installed the brackets and flower planters along Cloquet Avenue and the West End this week. We've learned a few things in terms of timing and ordering of the flowers for the planters. The City has received some positive feedback already from the community. In future years, the flowers will need to be ordered in November/December to allow us to obtain the larger more fully grown pots. Being that this is the first year we've tried this, let us know your thoughts to help us plan for future years.

8TH STREET RECONSTRUCTION

The construction project is underway with the sanitary sewer work in the L& M parking lot being the first item of attention.

HWY 33/I-35 INTERCHANGE IMPROVEMENTS

Motorists traveling through the Highway 33/ Interstate 35 ramp intersection in Cloquet will notice that a new **"YOUR SPEED IS"** sign and other safety improvements installed by MnDOT.

RE: Dog Ordinance

Dear Mayor & City Council:

I am writing to discuss a couple of recent incidences with a dog (Pitt Bull) attacking my dogs. I cannot recall the exact dates but in both instances we did call the police so this should be a matter of public record. In both instances our dogs were not seriously harmed. This was more due to my husband arriving quickly on the scene & literally holding the dog at bay. I was not home on the first occasion but I was in the yard on the second one.

After the first incidence I waited a few days, then I went to the police station where I was assured I will be notified as to how the situation would be handled. I to date have never heard anything back.

The Pitt Bulls again got loose the following Sunday & headed directly to our yard but as luck would have it, our dogs were in the house. So no harm but it was obvious these dogs are not being properly confined.

The last incidence happened when I was in the yard & again the Pitt got loose. He/She immediately headed to our house where our dogs (Yorkies) were tied up. There was no where for them to go because of being tied. They were screaming so loudly I was sure they were badly hurt. They were not. My husband heard my screams, came running & again removed the Pitt from our dogs. The police were called & as pleasant as the officer was, we were informed that dogs attack other dogs – that is just in their nature. However if our dogs were hurt we would be able to go after the people in Civil Court. The owners of the dog indicated they would be removing the dog on May 7th. I do not know if that has happened or not. Neighbors have said this has not happened.

My reason for writing this letter is to find out what our rights are when there is a leash law in this town and, there is obviously a dog in our neighborhood that attacks other dogs. Do we just wait for one or more of our dogs to get killed & then deal with Civil Court? What about our little grandson if he is outside when this dog decides to attack our dogs? Do we just tell his parents if he gets hurt that dogs will be dogs & it is in their nature to attack other dogs and oh by the way, your son just happened to be in the way when this happened?

We have previously lost one of our dogs to two malamutes that got loose. As much as we were upset my real issue here is the safely to the public (children).

Why can't something more be done when there is an animal attacking other animals? What are our rights? If this happens again, I don't know if the dog will be held for police because so far other than telling us there is nothing they can do, we don't really see the point in calling.

I also want you all to just stop & think if your little grandchild/child would be playing in your yard when you know there is a Pitt Bull out there attacking other animals- what exactly would you want done? Do you truly just want to take someone to Civil Court after an incident or try to prevent a tragedy?

LIBRARIAN'S REPORT

382 ebooks and 285 downloadable audiobooks were checked out by Cloquet patrons in March. The library checked out 9,680 items in March and public computers were accessed through Cybrarian 1,620 times. Ancestry Library Edition was searched 2,080 times with 690 images and 582 text downloaded in March. Newsbank was accessed 3 times. Our web page had 3,916 sessions according to Google Analytics.

Reminder: The Foundation has a couple of fundraisers coming up. There will be a quilt raffle as part of the One Book One Community project. The Pine Needle Quilters generously donated a quilt for the raffle. The drawing will be at noon on April 28. Linda LeGarde Grover will draw the winning ticket. There will be a quilt show at the library during the day. The other fundraiser is a craft show this summer, on the library lawn, on Friday, June 19 from 10 a.m. to 4 p.m.

The Friends of the Library Book Sale is on May 2 from 9 a.m. to 1 p.m.

I have been working on an application for a Blandin Community Broadband grant that would include Carlton and Moose Lake libraries. The intent is to have the three libraries as Wi-Fi hot spots and offer instruction in app technology through the use of iPads.
