Administration/Finance

The City is working on the final bid documents for the renovation of the MCCU building into the new City Hall/Police Department. We hope to be occupying the building in April 2019. With the upcoming move, we have been scanning a sizeable number of documents for electronic retention and destroying the originals which drastically reduces the amount of paper documents that will need to be moved to the new facility.

The November 6th General Election is quickly approaching and staff has been busy making sure our election judges are prepared and ready for Election Day. We are always looking for extra judges so if you know of anyone who would like to be a part of the election process, please have them contact Kris at kstarnold@cloquetmn.gov or by calling City Hall.

Finance

Please use the updated Expense Reimbursement form when turning in any expenses after October 1, 2018. The updated form is on the city website and reflects a change in the daily meal rates.

Human Resources

The City will be offering its annual flu shot clinic on October 22nd from 11:45 a.m. to 1:45 p.m. at City Hall. The clinic will be available to City employees and family members who are at least 3 years of age. No appointment is needed, just stop by during that time with your insurance card and an ID.

Public Works/Parks

Cloquet Avenue construction is beginning to wind down with only electrical and a few pavement markings remaining. The base lift of pavement was placed on the final phase of our West End reconstruction project and only a couple blocks of sidewalk, driveways and a final lift of pavement remain to be completed.



On a sad note, the City's winter sand and salt supply has arrived at the garage over the past week. Street department staff will spend much of the next two weeks brining, mixing and preparing for snow.

Economic Development

The Cloquet EDA met this week and reviewed the new draft EDA Website, strategized details on a business meeting event with Minnesota Power scheduled for next week and reviewed a draft

marketing youtube video on EDA information.

EDA members held a roundtable on local issues and noted a ribbon cutting scheduled for the White Pine Apartment Project Tuesday, October 9th at 11 a.m. where Councilor Bjerkness will be speaking on behalf of the City.


Library

Enclosed is the monthly financial report and cash and investment analysis for August 2018.

Cash and Investments

Cash balances are 12% below August 2017, mostly due to the City Sales Tax Bond issued in May 2017 being spent on projects. A narrative and several spreadsheets discussing this month's cash and investment activities, and balances are attached.

Budgets

<u>Revenues/Transfers in</u> – Most revenues are in line with budget except rental inspector charges have not started since a rental inspector has not been hired to date.

 $\underline{\text{Expenditures/Expenses}}$ – Selected department and fund expenditures/expenses are analyzed on the following worksheets.

Major Revenues and Expenditures/Expenses

Revenues:

State \$84,300 for City Sales Tax, \$21,000 for Post Board Reimbursement (we usually get \$7,000 but the aid is increased for two years because new training requirements were added), \$24,200 for municipal street aid final 2017 allocation, and \$97,700 for the final Slate Street sidewalk project.

Expenditures/Expenses:

S E H \$57,600 for various project studies and water treatment plant design. Boldt \$57,900 for Skate Park construction. Ulland Brothers \$333,500 for the Dunlap/Broadway project and Cloquet Avenue project. George Bougalis & Sons \$275,400 for the Arch Street project. Dodge of Burnsville \$50,700 for two police vehicles.

City of Cloquet Cash and Investments Management Summary August 31, 2018

Analysis of Portfolio

Attached is a "Cash and Investment Analysis" which shows the type of accounts and values that make up the City's cash and investment portfolio.

Current Economics

The economy is still on the slow but steady pace. The State's budget and economic outlook has improved since the February forecast. The 2018-2019 biennium has a projected surplus of \$348 million. The 2020-21 biennium has a modest structural balance forecasted. The near-term US outlook is steady but trade tensions are escalating. Unemployment is at 3.9% for August.

The City's certified 2019 LGA is \$2,485,000 approximately \$7,000 more than 2018 and the City increased its levy by 2.26% for 2018 and the 2019 preliminary is 1%. The City changed health insurance providers and will save a significant amount in 2018. The 2019 health insurance rates are 3.06% more than 2018.

Current Activity

During the month of one municipal bond for \$260,000 and one CD for \$245,000 matured in August. Proceeds are sitting in the money market which is earning almost as much as the average CD rate the City currently has. The money market accounts are accumulating a large amount of cash for the MCCU building purchase and remodeling. The City also has large capital projects this summer. Attached is an "Investment Portfolio Analysis" with the detail of investments.

Variance Analysis

Cash and investments are 12% below August 2017. The decrease is mostly due to the spending of the City Sales Tax Bond issued in May 2017.

The federal benchmark interest rate was raised for the second time in 2018 during the June meeting to 1.75% to 2%. The Fed announced there is likely going to be two more increases in 2018. Attached is an "Interest Earnings Analysis" which details the average balances invested, rate of return, and prior year rates.

The budgeted interest earnings are \$326,000 for 2018. The City's investment annualized yield is approximately \$221,000 or 1.74% plus another \$120,000 in money market interest for 2018. Interest receipts were \$309,000 for 2017.




