## **PUBLIC HEARINGS**

City Administrator Peterson announced now is the time and place for the public hearing on the proposed 14th Street utility reconstruction project. Due to the public hearing being virtual, City Council will act at the October 20th meeting so the public has more time to comment.

John Anderson, Assistant Public Works Director, gave an overview of the utility work to be completed. Mr. Anderson explained due to the size of the project, it will take place over 2 construction seasons. If council decides to proceed with the project, it will begin spring of 2021 with an assessment hearing in 2022.

Dan Hinzmann from SEH provided background and an overview of the project that included the roadway design, utility design and overall construction impacts.

City Administer Peterson explained this project will utilize sales tax dollars.

# **SALES TAX PROJECT DISCUSSION**

Administrator Peterson explained the option of seeking an additional .5% sales tax to fund future ice arena improvements along with other potential projects at Pine Valley. Since the last sales tax bill, State rules to see such funding have changed and now require project specific funding with regional impacts. Mr. Peterson reviewed a list of potential qualifying projects for the ice arena and Pine Valley as a whole. Council members agreed to move forward with seeking the additional .5% sales tax.

#### IN PERSON MEETING DISCUSSION

Administrator Peterson asked for Council input on moving back to in-person meetings. Council would like to continue virtual meetings and bring back for further discussion in November.

# **COUNCIL COMMENTS, ANNOUNCEMENTS, AND UPDATES**

Candidate forum will take place on October 21st via live streaming through the city's website.

City Hall hours have gone back to regular hours, 7:30-4:00.

Administrator Peterson asked for Council's feedback on the Home for the Holidays parade and fireworks. Due to COVID-19, Council agreed cancelling both parade and fireworks is in the best interest of the health and safety of the community.

Councilor Lamb noted the vacancy on the CAFD Board.
