PUBLIC WORKS TRUCK PURCHASE REVISION

MOTION:

Councilor Swanson congratulated the organizers of Santa's Home for the Holidays on the success of the weekend's events. The amount of people taking part indicates the community's need to get back to normal.

Administrator Peterson inquired how Councilors would like to proceed with his annual evaluation. Mr. Barclay will send out the evaluation form to Councilors to complete. It was agreed they would like to conduct a verbal evaluation in a closed session at the December 21st Council meeting.
