AUTHORIZING WATER SUPPLY PLAN CONTRACT

MOTION:

Councilor Kolodge moved and Councilor Carlson seconded the motion to approve RESOLUTION NO. 22-43, ENTERING INTO AN AGREEMENT WITH SAMBATEK FOR AMENDMENTS TO CLOQUET'S WATER SUPPLY PLAN. The motion carried (5-1), Councilor Jaakola opposed.

WHEREAS, The City of Cloquet and Sappi wish to request an amendment to the Lake Superior Waterline Allocation from the Minnesota Department of Natural Resources (DNR); and

WHEREAS, An amendment to the city's current Water Supply Plan addressing water conservation measures is required before such a request can be made; and

WHEREAS, Sambatek drafted the city's existing Water Supply Plan which was adopted in 2016; and

WHEREAS, City staff has solicited a proposal for professional services from Sambateck to make the necessary amendments and found it to be acceptable.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF CLOQUET, MINNESOTA:

That the City of Cloquet enter into an Agreement with Sambatek for professional services in the estimated amount of \$15,000.

IT IS FURTHER RESOLVED that the City Engineer is authorized to execute the agreement and any amendments to the agreement as needed.
