- Highlights of the 2021 Annual Report were shared. The report is "locked" at the state level at the present time therefore copies could not be made for board members. When the annual report is approved at the state level, it can be printed and it also will be added to the library's website.
- The library staff is wondering if it would be a desired and useful service to the community if the library were open on Saturdays in the summer. The library staff would be willing to try it if there was additional staff on Saturday. Casey Brissett made a motion to approve the library being open on Saturdays in the summer if the additional staffing condition is met. Following a second by Gerard Sordelet, the motion was approved.
