<u>AUTHORIZE THE FIRST AMENDMENT TO DEVELOPMENT AND PURCHASE</u> AGREEMENT WITH BOSS BUILDERS

MOTION: Councilor Keller moved and Councilor Jaakola seconded the motion to approve

RESOLUTION NO. 23-25, AUTHORIZING THE FIRST AMENDMENT TO DEVELOPMENT AND PURCHASE AGREEMENT BETWEEN THE CITY OF

CLOQUET AND BOSS BUILDERS FOR REDEVELOPMENT OF THE FORMER 611 ADAMS STREET SITE. The motion carried unanimously (7-0).

A. WHEREAS, Boss Builders (the "Developer") has requested the City of Cloquet, Minnesota (the "City") to amend the Development Agreement covering Tract A and Tract B at the former 611 Adams Street site, defined hereafter (the "Property"), and to reduce the bedrooms in each unit from three to two and to reduce the originally proposed garage size from 24' x 24' to 22' x 22' on the Property by the Developer (the "Project").

B. WHEREAS, the Developer and the City enter into a Development and Purchase Agreement on November 16, 2021 providing for the sale of the Property by the City for this Project (the "Development Agreement").

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF CLOQUET AS FOLLOWS:

The City Council hereby approves the First Amendment to the Development and Purchase Agreement (attached), and the Mayor and Administrator of the City are hereby authorized and directed to execute on behalf of the City.

AWARD CONTRACT FOR STORM DEBRIS REMOVAL

to 3D Construction for storm debris removal in the estimated amount of \$48,800.00. The

Administrator Peterson gave a brief update on Legislation stating that the Lake Superior waterline bonding bill is still included and has no changes; Local Government Aid is a part of a larger budget bill and still includes a larger increase into LGA which will help offset projected losses for next year with enough left over to help with other projects; and the legalization of marijuana continues to move through

House and Senate and they are working on the language. Staff will continue to watch that progress a	and
stay on top of any dates and deadlines resulting in updates to our City Code.
