#### **PRESENTATIONS**

a. Planning Commission 2022 Review and Update City Planner Al Cottingham and Planning Commissioners Teri Lyytinen and Elizabeth Polling reviewed 2022 activities of the commission. In 2023, they will be amending the zoning ordinance by adding language for Sacred Communities and Micro-Unit Dwellings based on changes to state law which will take effect January 2024. The commission will also be looking for guidance from City Council on amending the zoning ordinance to include cannabis dispensaries and allowable locations as well as the number of them. Staff anticipates the state will have requirements established later in 2024 so there is time to discuss details and for the amended ordinance.

#### b. 2022 Financial Presentation

Michelle Swoboda from WIPFLI presented the 2022 Annual Comprehensive Finance Report. Swoboda noted the audit resulted in an unmodified, or "clean" opinion of the 2021 Annual Comprehensive Financial Report. Swoboda mentioned the city's total net position decreased from \$66,093,710 in 2021 to \$65,947,030 in 2022. Revenues totaled \$18,800,000 while expenditures totaled \$18,948,000 in 2022, resulting in the previously mentioned decrease in net position. The city's governmental funds balance decreased by \$112,000 in 2022 to an ending balance of \$8,110,000. In 2022, governmental funds expenditures exceeded governmental fund revenues by \$112,000, resulting in the net decrease in the fund balance. Total 2022 general fund revenues were \$166,000 more than budgeted, while expenditures were \$132,000 more than budgeted. The city's proprietary funds had an operating income of \$410,000. The proprietary funds had an overall decrease in net position of \$1,744,000 in 2022.

## UPDATED DRUG AND ALCOHOL TESTING POLICY FOR NON-COMMERCIAL DRIVERS
