## City of Cloquet Advisory Boards and Commissions

Members are appointed by the City Council at a regular meeting of the Council as required and as terms expire. To serve on any Board, other than the Economic Development Authority or Cable TV Commission, you must reside within the City limits of Cloquet. Most groups meet on a monthly basis.

**Cable TV Commission** - Composed of six (6) members. This Board addresses issues which affect the local cable TV and Public Access Channels (CAT7). Members represent Thomson Township as well as the cities of Cloquet and Scanlon.

*3 year term - Meets quarterly or on an as needed basis.*

**Economic Development Authority** - The Authority will focus efforts on economic development in order to retain current businesses and help promote growth of new businesses. The Board is composed of seven (7) members, including five (5) at-large and two (2) Council members.

*6 year term - Meets the first Wednesday of every month at 8:00 a.m. at City Hall.*

**Housing & Redevelopment Authority** - The municipal Housing and Redevelopment Authority is composed of five (5) members. The Authority addresses housing shortages for low and moderate income residents and manages local subsidized housing units.

*5 year term - Meets the 2nd Tuesday of every month at 7:30 a.m. (or as needed) at Aspen Arms.*

**Library Board** - Composed of seven (7) members. The Board provides operation and management direction for the administration of the Public Library.

*3 year term - Meets the last Tuesday of each month at 4:15 p.m. in the Library Conference Room.*

**Parks Commission** - Consists of seven (7) members. This Advisory Commission is responsible for the oversight of all park operations including land acquisition, development, improvement and use, and maintenance.

*3 year term - Meets the 1st Monday of each month at 4:30 p.m. at City Hall or various parks.*

**Planning Commission** - Composed of seven (7) members. This is an advisory commission to the City Council concerning comprehensive planning, zoning, platting, changes in streets, variances from the Zoning Ordinance, and other matters of a general planning nature.

*3 year term - Meets the 2nd & 4th Tuesday of each month at 7:00 p.m. at City Hall.*

**Citizens Advisory Board** - Composed of three (3) members. This Commission is responsible for the process of making recommendations to the Council for all hiring and disciplinary actions within the Police Department.

*3 year term - Meets as needed.*

**Shaw Memorial Library Foundation** - Composed of seven (7) members. The Foundation is responsible for raising funds to expand and maintain public library operations.

*3 year term - Meets as needed.*
