

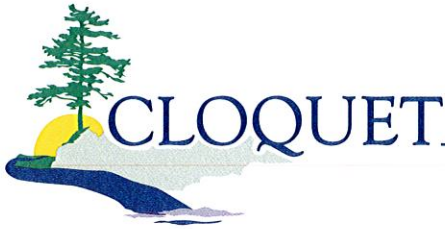

**ITEM DESCRIPTION:** Consideration of Resolution Determining Results of City Primary Election

**Proposed Action**

Staff recommends the City Council move to adopt **RESOLUTION NO. 16-62, CERTIFYING 2016 MUNICIPAL PRIMARY ELECTION CANVASS.**

**Background/Overview**

The City Primary Election was conducted on Tuesday, August 9, 2016 in conjunction with the State Primary Election. The Primary Election for Cloquet involved the following positions:

**Policy Objectives**

Minnesota State Statute 205.065, subd. 5, states that in conjunction with a State Primary, the canvass may be conducted on either the second or the third day after the Primary. The County Auditor has informed the City that it may hold its canvass meeting on Thursday, August 11, 2016. Therefore, the Council must either conduct the canvass on August 11 or 12, 2016.
