CLOQUET CITY COUNCIL WORK SESSION

2014 FINANCIAL AUDIT REVIEW

Deborah Medlin from Wipfli, LLP, shared various schedules and reports from the City's 2014 CAFR. Highlighted items are as follows:

- Nancy Klassen will receive the 2014 Certificate of Achievement for her excellence in financial reporting. Kudos to Nancy!
- Ms. Medlin discussed the budget and actual results for the General Fund, noting fund balances are where they should be.
- Sewer fund negative balance is due to Sappi's decrease in usage, which is out of the City's control. Ms. Klassen stated another rate increase is being discussed and Public Works has been made aware to determine if there is a meter issue or a change in flowage amount.
- Ms. Medlin reviewed the Independent Auditor's report and their responsibility to follow auditing standards, resulting in a clean report.
- The complete CFAR will be available on the City website.

WATERFRONT MASTER PLAN REVIEW

Mr. Fritsinger stated the Waterfront Master Plan is on the Council agenda for final acceptance. Detail of the plan will not be discussed at the meeting, but a broader background will be given. Mr. Fritsinger then gave an overview of the history of the project to this point and the components of the plan including rough estimates, previous meetings with SEH prioritizing projects and processes. Items were pulled together and summarized to serve as a guide.

Mr. Fritsinger acknowledged the critical issue for much of the master plan process is funding. Opportunities to leverage dollars may include a sales tax increase and Legacy Grant monies. Caleb Peterson has attended trainings on the Legacy monies to learn the qualifications and process. Caleb shared the following information on the Legacy Fund process:

- Legislature has recently created the Greater MN Trails and Parks, and it is now a 2 step
 process. Applicants need to designate the location as a regional facility, which the City
 is in the process of now. A Master Plan needs to be adopted to be eligible for the
 funding and to meet requirements. If selected, the City would be ready to go forward
 with plan. There is no match requirements for Legacy Funds.
- This may also be a source of funding for a possible trail expansion project.
- The City will be notified by July of the status on Legacy award. The Legacy Grant is very competitive, Caleb is researching other funding options.

Mr. Fritsinger feels we are at a place where the plans can be stacked up against each other. \$4.5 million going forward from the .5% sales tax, with the Pinehurst Park project being the first and going forward this summer.

Mr. Fritsinger then reviewed the current draft CIP park projects timeline from 2016 through 2019. Projects include the River Front north shoreline, Pine Valley bike trail development, regional trail development, Braun Park field improvements, and Athletic Park redesign and development.

The City was recently approached about the acquisition of private property on Dunlap Island. This opportunity could further the recommendation of the Master Plan. Benefits of purchasing the property would allow the City to deal with the issue of ATV traffic through campground by extending the trail system. The Council was in agreement to have further discussions with the property owner.

Mr. Fritsinger discussed park projects as follows:

- Skate Park location has not been identified. The City maintains their part in funding remains at \$100,000.
- Fauley Park discussion on beautification of the property. Mr. Fritsinger is not in favor of
 covering the train. Total project amount is \$150,000, vs SEH's estimate of \$800,000,
 which included covering the train. More discussion of options will take place at a later
 date. The Council was supportive of a scaled back project being completed at Fauley
 before Wentworth Park.
- Veterans Memorial/Stage plans identify a wall surrounding the memorial with a stage constructed on the back side. A stage that size would accommodate 90% of the activities at the park.
- Other identified projects include Skyline/North River Front trail landscaping and beautification in 2017; Dunlap Island, minus any work on the bridge also in 2017; Regional Trail/River Front in 2018; Pine Valley Bike Trail and Chalet, 2018; Vets Park Entry, 2019; Braun Park Irrigation, 2020; Athletic Park 2021; and Vets Park picnic shelter 2022.

Discussion on the timeline included the aggressiveness of the timeline. Comments on the priority of Pine Valley, noting it is a gem in in the center of the City. Can Veteran's Entry Plaza move up in priority to 2017? Mr. Fritsinger's response was yes.

Mr. Fritsinger stated the Parks Commission hasn't looked at any of this yet. Feedback and input will be needed from them as well. The presented layout shown tonight is only the first round of projects.

LONG GRASS PROCEDURES

MOTION:

Councilor Kolodge moved and Councilor Wilkinson seconded the motion to adopt ORDINANCE NO. 448A, AN ORDINANCE AMENDING SECTION 7.2 OF CITY CODE RELATED TO LONG GRASS PROCEDURES. The motion carried unanimously (7-0).

The City Council of the City of Cloquet does hereby ordain as follows:

Section 1. That Section 7.2.01 be amended to add the following definition:

H. Vegetation Public Nuisance. Any weeds or grass growing to a height greater than six (6) inches or which have gone or are about to go to seed, all accumulations of noxious weeds, other rank growths of vegetation, fallen trees, dead tree limbs or invasive brush that is injurious to managed landscapes, lawns and the natural flora of the City, are declared to be a nuisance condition and a hazard to the public health, safety and good order of the City, whether found upon public or private property.

Section 2. That Subsections A, B, C and D of Section 7.2.06 be deleted and replaced with the following:

7.2.06 Grass and Weeds on Private Property.

A. It shall be unlawful for any owner, occupant, or agent of the owner of any lot or parcel of land in the City to allow noxious weeds to grow on any such lot or parcel or to allow grass and weeds upon any such lot or parcel to grow to a height in excess of six (6) inches or to allow such weeds or grass to go to seed, or to otherwise maintain a vegetation public nuisance. Grass or weeds can be grown to a height in excess of six (6) inches or allowed to go to seed without being deemed a vegetation public nuisance in the following circumstances:

The area of the lot or parcel constitutes wetlands or a wetland buffer area; The area in question is a storm water pond; The area in question is heavily forested; The area in question is a park or nature preserve; The area in question is a natural area not to exceed a quarter of the lot; The area in question is deemed agricultural land and is used as such; The area in question is on a slope in excess of a slope ratio of 3 to 1.

- Β. If any such owner, occupant or agent fails to comply with this height limitation or otherwise maintains a vegetation public nuisance, and after an abatement notice given by the City Administrator or his designee, has not within five (5) days following service of such notice complied, the City shall cause such grass or weeds to be cut or otherwise abate such vegetation public nuisance and the expenses thus incurred shall be billed to the property owner. and any outstanding charges unpaid on the fifteenth (15th) of November following said abatement shall be made a special assessment and become a lien upon such real estate. The notice shall contain a description of the nuisance condition to be abated and a general notice that the City may abate future violations of Section 7.2.06(A) throughout the rest of the growing season without providing additional specific notice for the same type of vegetation public nuisance violation. This notice shall remain in effect through October 31st of the year in which it is sent. The City Administrator shall be authorized to certify to the Carlton County Auditor a statement of the amount of the cost incurred by the City. Such amount together with interest shall be entered as a special assessment against such lot or parcel of land and shall be collected in the same manner as real estate taxes.
- C. All individual notices provided for herein may be served personally or may be served by mail. Service by mail shall be complete upon mailing to the property owner at the address listed on the current property tax statement for that parcel, as found in the records of the County Auditor or Treasurer's office, and following posting of the notice upon the premises.
- D. The bill to the property owner for the abatement of a vegetation public nuisance shall state the amount and basis for the costs, and shall include the same general notice as contained within the abatement notice, that the City may abate future violations of Section 7.2.06(A) throughout the rest of the growing season without providing additional specific notice for the same type of vegetation public nuisance violation. The bill shall further provide notice that any outstanding charges unpaid on the fifteenth (15th) of November

following said abatement shall be made a special assessment against such lot or parcel of land and shall be collected in the same manner as real estate taxes, and that any objection to such assessment must be made in writing to the City Administrator prior to that date. The notice shall also provide the time, place and date of a hearing before the City Council to determine the validity and the amount of the proposed assessments, and shall state that no objections thereto shall be heard unless properly made in writing to the City Administrator as provided above.

Section 3. Effective Date. This ordinance shall take effect and be in force from and after its passage and publication in accordance with law.

ITEM DESCRIPTION:

Approval of Rivdogg, LLC. On-Sale Liquor License

Proposed Action

Staff recommends the City Council move to approve the On-Sale Intoxicating Liquor License for Rivdogg, LLC, 207 Avenue C, consistent with the diagram submitted and the Sunday On-Sale Intoxicating Liquor License subject to receipt of a qualifying restaurant license from the State of Minnesota, criminal background check, and final inspection of the premise by the City Building Official.

Background/Overview

The City has received an application from Douglas Smith, 5201 Oneida Street, Duluth, seeking to obtain a new On-Sale Intoxicating Liquor and Sunday On-Sale Intoxicating Liquor License at 207 Avenue C. The applicant is in the process of obtaining a building permit to renovate the space into a restaurant.

Mr. Smith has entered into a Lease Agreement with the owner of the building.

- On-Sale Intoxicating Liquor The applicant has submitted all of the necessary materials. A criminal background check is currently underway. The applicant is seeking to license the area as identified on the attached floor plan. The sale of alcohol is limited to the floor plan area.
- Sunday On-Sale Intoxicating Liquor The applicant is applying for a Sunday On-Sale License. Under City Code and Mn. Statute, an establishment must be licensed as a qualifying restaurant in order to be open for alcohol sales on Sunday. At the time of this submittal, the applicant has not yet obtained a Restaurant License, but has applied for a Medium Establishment License. The applicant will be required to provide proof of such license to the City before the Sunday On-Sale License will be issued.

Upon approval of the On-Sale Intoxicating Liquor License, the license will be categorized as a Restaurant On-Sale Intoxicating Liquor License. Both licenses would have an expiration date of June 30, 2016.

Request for Council Action Rivdogg, LLC. On-Sale Liquor License July 2, 2015

Policy Objectives

Approval of On-Sale Intoxicating Liquor Licenses are required under Chapter 6 of the City Code and Mn. Statutes 340A.404 under State law. As a statutory city of the third class, the City is limited to a maximum of twelve (12) licenses. However, in 1987, the City held a special election which resulted in the authorization of one (1) additional license.

Under this same section of law, the State also provides certain exclusions from license limits. Restaurants are one of the excluded categories. In other words, a license issued as a Restaurant does not count towards the City's total of thirteen (13) licenses. As noted above, this license shall then be categorized as a Restaurant On-Sale, thus not impacting the remaining number of On-Sale licenses.

Financial Impacts

The City's fee schedule requires each license holder to pay set fees for each license. The total fees received by the City for alcohol licenses are required to be consistent with the level of service to administer and enforce local liquor laws. The applicant has paid all fees which are required by the City.



Parks Maintenance Person Appointments

Proposed Action

Staff recommends that the City Council move to approve the one year probationary appointments of Andrew Chalberg and Karin Stedman to the position of Parks Maintenance Person in the Public Works Department. Mr. Chalberg's effective date is July 8, 2015 and Ms. Stedman's effective date is yet to be determined.

Background/Overview

This past May, the City Council authorized the hiring process of a Parks Maintenance Person position. This position was a new position created as a result of City Council goals/priorities. Subsequently, our current incumbent resigned his position with the City, thus two openings were available.

In May/June, the City completed all of its due diligence required and posted the position vacancies as required under the AFSCME labor agreement. No members of the AFSCME unit posted for the position. The City then advertised publicly, received applications, and conducted interviews with several qualified candidates.

Through this interview process, the City identified Mr. Chalberg and Ms. Stedman as top candidates, both whom have accepted the City's preliminary offer of employment subject to City Council approval. Mr. Chalberg currently is working with the City as a summer seasonal temporary employee.

Policy Objectives

The Department currently is responsible for the maintenance of all parks and functions with two people. The parks maintenance duties are shared with the five members of the street department. Keeping a fully staffed department is consistent with the service level directives of the City Council.

The City Council is the hiring authority for the City as determined by City Code and State law. The City Council must act to appoint this individual to complete the hiring process.

Financial/Budget/Grant Considerations

These positions are currently fully funded as part of the adopted 2015 operating budget. Wages and benefits for the position are budgeted at approximately \$50,000.

Advisory Committee/Commission Action

An interview panel has recommended Mr. Chalberg and Ms. Stedman as the top candidates.

As part of his most recent annual performance evaluation the City Engineer has recommended that Mr. Johnson be promoted to the Tech II position. Prior to the hire of Mr. Johnson the City had two Tech II positions.

Policy Objectives

The City Council is the hiring authority for the City as determined by City Code and State law. The City Council must act to promote this individual to complete the process. The promotion is allowed as part of the AFSCME union labor agreement.

Financial/Budget/Grant Considerations

This promotion will require a budget adjustment and will be planned for inclusion in the 2016 operating budget. The difference in pay at Step 9 of the City's adopted pay plan is approximately \$3,300.

Staff recommends the City Council move to adopt RESOLUTION 15-53, APPROVING A TEMPORARY ACCESS AGREEMENT WITH THE MINNESOTA DEPARTMENT OF NATURAL RESOURCES AT CLOQUET PUMP STATION #2.

Background/Overview

Over the past few years, the City Engineer's Office has been meeting and working with the MN Department of Natural Resources (DNR), MPCA, City of Duluth and Army Corps of Engineers regarding an erosion control and stream restoration project along Knowlton Creek, which runs alongside Cloquet's Lake Superior Waterline Pump Station #2 in Duluth. The goal of this project is to stabilize soil erosion that has been taking place for years in this area. This erosion has resulted in large amounts of sediment being deposited into Knowlton Creek and ultimately into the St. Louis River Estuary. To accomplish some of the work in the area, the DNR is requesting approval of a Temporary Access Agreement to cross property owned by the City of Cloquet at Pump Station #2 located at 8505 Knowlton Creek Boulevard. Additional information on the project is included in the attached Phase 2 Scope of Work. Also enclosed is a copy of the proposed Access Agreement.

The City Engineer is very familiar with this project and has been anxious to see work get started as the erosion taking place also has the potential of jeopardizing the stability of the Cloquet Waterline as it runs up and over this steep area of West Duluth's Spirit Mountain.

Policy Objectives

To work cooperatively with other public agencies to complete identified improvements of mutual interest and benefit.

Financial Impacts

All improvements completed under this project will be paid for with funds provided by the State and Federal governments and there will be no expenses to the City of Cloquet.

TEMPORARY ACCESS AGREEMENT

THIS RIGHT OF TEMPORARY ACCESS ("Agreement") is granted by the City of Cloquet, Minnesota ("City") to the State of Minnesota, acting by and through its Commissioner of the Department of Natural Resources ("DNR").

WHEREAS, the City is the owner of the subject Property ("Property") described as follows:

That part of the Southeast Quarter of the Southeast Quarter of Southwest Quarter (SE1/4 of SE1/4-SW1/4) and the West Half of Southwest Quarter of Southwest Quarter of Southeast Quarter (W1/2 of SW1/4 of SW1/4-SE1/4) lying North of Knowlton Boulevard, in Section Fourteen (14), Township Forty-nine (49) North, Range Fifteen (15) West of the Fourth Principal Meridian in Saint Louis County, Minnesota, comprising 7.55 acres, more or less, as shown on the map attached to this Agreement as Exhibit A; and

WHEREAS, the DNR desires to use the Property to stage and access certain portions of the Knowlton Creek for stream restoration purposes (the "Project"). A description of the Project is attached to this Agreement as Exhibit B; and

WHEREAS, the City and the DNR desire to set forth the terms and conditions under which DNR can use the Property for its Project;

NOW THEREFORE, the City does hereby grant to the DNR a temporary and non-exclusive limited right of access to enter in and upon the Property under the following terms and conditions.

1. <u>Temporary Right of Access</u>: For the term of this Agreement effective as of the last date of the execution of this Agreement (the "Effective Date"), the DNR and its agents and contractors shall have the right to access the Property for ingress and egress for its equipment including backhoes, dump trucks, dozers, and other heavy equipment as well as temporary equipment used for the Project. Except as provided for in the previous sentence, the permission granted herein shall not be transferrable or assignable to any third party. This Temporary Right of Access is granted and accepted on as "as is" basis with respect to the Property and its condition.

- 2. <u>Term and Termination</u>. The Term of this Agreement shall be for a period of Thirty-six (36) months from the last date of signature below. This Agreement may be terminated by either party for any reason or no reason upon the giving of fifteen (15) business days' written notice to the other party as hereinafter provided.
- 3. <u>Fees.</u> No payment shall be made by the DNR to the City for this Agreement.
- 4. <u>Use and Maintenance.</u> a) The DNR may construct one or more temporary access roads within the Property for ingress and egress to Knowlton Creek. Such roads shall be constructed in a manner which minimizes long term damage to the Property. The DNR shall maintain all temporary roads (grading and snow removal) within the Property at DNR's expense. All temporary roads shall be deemed to be part of the Property.
- b) The DNR may remove trees and shrubs on the Property to access Knowlton Creek, shift the stream channel, and for use in the Toe Wood/Root Wad structures along portions of the stream.
- c) All equipment shall arrive on and leave the Property in a clean condition, free of mud, dirt and debris, to reduce the likelihood of spreading invasive species. No fueling or oiling of equipment shall occur on the Property without a Spill Prevention Control and Containment Plan approved by the City's Director of Public Works or designee.
- d) The DNR shall perform all activities on the Property in a good and workmanlike manner. The DNR shall take necessary precautions for the safety of its equipment and employees, and to the general public as a result of DNR's use of the Property.
- e) Notwithstanding the foregoing, nothing in this Agreement shall render the DNR or its agents and contractors responsible for any pre-existing contamination, pollution or other hazardous materials on the Property.
- 5. <u>Costs.</u> The DNR shall be responsible for the costs of all labor, service, equipment and materials used in the Project and shall not permit any lien or encumbrance upon the Property resulting from its activities on the Property.
- 6. <u>Surrender of Possession, Restoration.</u> Upon the expiration or other termination of this Agreement, the DNR's rights to use the property shall cease and DNR shall promptly surrender

the same to the City. The DNR agrees that upon termination of this Agreement, it will have restored or repaired, to the reasonable satisfaction of the City's Director of Public Works, all modifications of, or damage to, or destruction of the property which were altered, damaged or destroyed by the DNR under the authority of this Agreement or as a result of the DNR's exercise of its rights under this Agreement, or in the alternative, to pay the City for the cost of returning them to said condition unless waived by the City's Director of Public Works in writing.

- 7. <u>Liability</u>. Each party is responsible for its own acts and omissions and the results thereof to the extent authorized by law and shall not be responsible for the acts and omissions of the other party and the results thereof. The DNR's liability shall be governed by the provisions of the Minnesota Tort Claims Act (Minnesota Statutes, section 3.736) and other applicable law. The liability of the City is limited to the extent set forth in Minnesota Statutes Chapter 466.
- 8. <u>Compliance</u>. All activities conducted by the DNR pursuant to this Agreement shall be in compliance with all applicable state and federal laws and regulations.
- 9. <u>Taxes.</u> The City shall pay when due all taxes and assessments levied against the Property or the improvements thereon.
- 10. <u>Notice.</u> Proper service of any notice under this Agreement shall consist of the depositing in the United States mail with proper postage and addressed to the following:



The Minnesota Department of Natural Resources plans to restore and enhance habitat for trout and associated cold-water organisms, using Natural Channel Design techniques, to stabilize approximately 6,491 linear feet of Knowlton Creek and its tributaries in Duluth, Minnesota.

Snowmaking operations associated with Spirit Mountain Recreation Area add approximately 20% more water to the main stem of Knowlton Creek than the watershed's yearly moisture budget. Additionally, snowmelt and rain events run off more quickly to Knowlton Creek as a result of the semi-impervious surfaces of the ski runs. The other primary impairment identified is associated with the City of Cloquet Drinking Water Pumping Station, which pushes water up and over the hill. Backflow during power outages had been released directly into the tributary of Knowlton Creek. These situations resulted in substantial degradation of the stream channel and movement of sediment to the St. Louis River estuary. The flood events of the last decade, highlighted by the 500-year flood that occurred in 2012, resulted in the major failure of a derelict railroad causeway and severe bank erosion on both the main stem and tributary to Knowlton Creek.

Specific components of the Knowlton Creek natural channel stream restoration project include: (1) adjusting the stream channel size; (2) establishing a hydraulic connection between the channel and floodplain; (3) stabilizing streambanks; and (4) enhancing vegetation in the riparian corridor.

SCOPE OF WORK

Knowlton Creek Phase II Geomorphic Stream Restoration Design Phase II, Duluth, MN

1. INTRODUCTION

The Scope of Work (SOW) outlines tasks and activities to be performed under IDIQ Contract W912QR-14-D-0005. For this Task Order, the Minnesota Pollution Control Agency (MNPCA) is serving as a cost-sharing non-Federal sponsor. The purpose of this SOW is to complete the stream restoration design for Knowlton Creek near Duluth, Minnesota. Major tasks/phases associated with this stream restoration design include coordination and design memorandum.

2. AUTHORITY

The authority for the project can be found under Section 401 of the Water Resources Development Act (WRDA) of 1990 (PL 101-640), as amended.

3. BACKGROUND

Knowlton Creek is a tributary to the St. Louis River, which drains to Lake Superior through Duluth-Superior Harbor in Duluth, MN. The 2.5 square mile watershed is primarily forested. The stream channel has been degraded by anthropogenic uses within the watershed including a ski area, an interstate highway, and a water pumping station. The degradation has deposited a large amount of sediment into the St. Louis River Area of Concern (AOC), filling in a shallow sheltered bay behind Tallus Island. A portion of the deposited sediment was dredged as part of the compensatory mitigation for the St. Louis River Interlake — Duluth Tar Superfund project.

Historic air photos of the St. Louis Estuary indicate that the onset of sediment deposition at the mouth of Knowlton Creek coincided with the opening of Spirit Mountain Ski Area and the establishment of a pumping station on the Cloquet Water Line. Snowmaking activities associated with the ski area have increased snowpack on the hill by approximately 20% above natural conditions, which greatly increases the flow and associated erosion and stream channel degradation during spring snowmelt/ runoff. Impairments have also been documented in association with heavy rain events. In addition, maintenance activities associated with the ski slopes have created dirt roads and trails on the ski slopes that are the source of the sediment to the system. The City of Cloquet water pumping station, which is located on a tributary to Knowlton Creek, infrequently discharges substantial amounts of water directly to the tributary due to power outages. This occurs roughly twice a year and has resulted in the severe degradation of the stream channel and sedimentation to the St. Louis River AOC.

A significant (<1% probability of exceedance) flood occurred in the watershed in June 2012. This flood caused the failure of an already deteriorating railroad grade at the upstream end of the proposed restoration area on the mainstem of Knowlton Creek. Large amounts of sediment were moved downstream, throughout the proposed restoration area.

In November of 2013, Stantec provided the Corps and the MNDNR with a 30% conceptual restoration design. This design takes into account the post-flood conditions of the watershed, as well as additional sources of sediment and watershed degradation above the Cloquet pump station.

4. PROJECT AREA




Figure 1: Reaches in the Knowlton Creek watershed included in the project area for this contract.

The general project area for the geomorphic assessment and stream restoration design shall consist of the Knowlton Creek watershed and the reference reach watershed. Specific project limits for Knowlton Creek and the reference reach are described below (see also Figure 1).

- For the Knowlton Creek main stem, the project limits shall extend from the confluence with the St. Louis Estuary upstream to the crossing at Interstate 35 and consist of the stream channel and the adjacent floodplain/stream corridor.
- For the Knowlton Creek tributary, the project limits shall extend from the confluence with the Knowlton Creek main stem upstream to the location of the City of Cloquet water pumping station and consist of the stream channel and the adjacent floodplain/stream corridor.

ITEM DESCRIPTION: Authorization to Bid 2015 Hilltop Park Improvements.

Proposed Action

Staff recommends that the City Council MOVE TO ADOPT RESOLUTION 15-55, APPROVING THE SOLICITATION OF BIDS FOR PLANNED 2015 PARK IMPROVEMENTS AT HILLTOP PARK.

Background/Overview

As part of the 2015 Capital Improvement Program (CIP) and approved budget, plans have been prepared to develop a forth athletic field and disc golf course at Hilltop Park.

Since it's redevelopment to an athletic field complex, Hilltop has become one of City's more heavily used parks. With a surge in the popularity of soccer and use of fields by the FDLTCC football program, finding a place to play or practice during certain times of year has become challenging. Unfortunately with increased use, maintaining a quality playing surface on the three fields has become challenge. Given the increase in demand and rising maintenance costs, staff and the Park Commission have identified development of a fourth field as a priority improvement. Once developed, it will be critical for City to negotiate use agreements with the College, Association, and School District in order to ensure future maintenance costs are born by the major users.

The development of a disc golf course in Cloquet was an improvement which received a large number of requests during the Park Master Plan development. At the time Hilltop was identified as one location to be considered. A low impact, low cost improvement, Staff estimates the total cost for disc golf improvements at approximately \$15,000.

The attached site plan illustrates the Park's final layout. Major contract work to be completed as part the bid includes clearing, grading, turf restoration, and access path construction. The budget also allows for extension of the existing irrigation system into the new field. It is anticipated that this design and construction will take place under a separate contract.

Request for Council Action 2015 Hilltop Park Improvements June 29, 2015

Policy Objectives

The proposed project improvements are in alignment with the Individual Park Plan concept identified in the January 2014 adopted Parks Master Plan. Also identified in the plan were a number of park policies of which the following apply in this case:

- Policy 1.3 Improvements to parks shall follow a process that engages park users, stakeholders, and neighbors to ensure changes are aligned with community needs and interests.
- Policy 2.5 All park resources shall be maintained in a way that ensures they are safe and attractive.

Financial/Budget/Grant Considerations

\$150,000 was included as part of the 2015 budget for said improvements. The estimated cost for this contract is \$80,000. Future costs include approximately \$15,000 for disc gold tees, signs and goals as well as \$30,000 for irrigation.

It is anticipated the project would be funded using sales tax revenues.
